

## CONDITIONS OF IMAGE REPRODUCTION AND USE (ARCHIVES COLLECTIONS)

The collections of MONOVA: Museum & Archives of North Vancouver (MONOVA) are an important resource for the study of the history of both the city and district of North Vancouver including individual lives, activities, families and communities. The usefulness of the archival and artifact collections also extends to numerous commercial and public relations applications. With this in mind, it shall be the policy of MONOVA to make available and accessible photographic images of its collections, and to permit their publication, subject to the following conditions and procedures:

### Conditions of Reproduction

1. All image reproductions will be handled through MONOVA. Self-copy privilege is granted only for non-profit, educational purposes where scans, digital shots, slide film, videotape or motion picture film may be used in which case a *Self Copy Agreement Form* must be filled out.
2. **The user assumes full responsibility for any infringement of copyright and for publication rights of reproduced materials.**
3. The ordering or taking of photographs and the payment of service fees DO NOT of themselves convey permission to publish.

### Conditions of Use

4. Non-commercial, Commercial and Public Relations uses of photographic images are defined as follows:
  - A: Non-commercial use is defined as any photography used by a non-profit organization; or as part of any not-for-profit scholarly enterprise, especially for educational purposes and/or cultural enhancement; or for personal study or reference.
  - B: Commercial use is defined as any photography used by a for-profit enterprise, or in any profit-making venture, for the purposes of creating, illustrating, advertising, marketing or commemorating a product. This includes any company contracted by government or non-profit organization to do the work.
  - C: Public Relations use is defined as any photography used by an individual, organization or business, which is deemed to have publicity, advertising or marketing value for MONOVA.
5. Express written permission is required from MONOVA prior to the publication of any image of objects or materials in MONOVA collections. An *Agreement Form for Use* must be filled out.
6. This form and only this form, signed by an authorized staff member of MONOVA, shall constitute such permission.
7. Individuals requesting permission to publish photographs of objects or materials in MONOVA Collection must reveal on this form the type, title, and date of the publication in which they want the images to appear, and the intended format of the image.
8. Permission to publish is extended only for the images listed on this form, and only for use in the manner described.
9. Permission to publish is extended for one-time use only. Additional uses require the further permission of MONOVA.
10. Payment is required in advance of the publication of any images.
11. Unless authorized in writing by MONOVA and noted in the credit line, images will not be shown with added colouring, superimposed, or transposed, or altered or cropped in any way that significantly changes the meaning or context of the image, or compromises its authenticity as an historical document.
12. In addition to obtaining written permission, individuals requesting permission to publish an image in a commercial publication, display or exhibition are responsible for paying a use fee. MONOVA may waive fees for the publication of an image in a non-commercial publication or for a use deemed to have educational or publicity value.
13. **MONOVA must be acknowledged as the source of any publication, exhibition, presentation, or any other display of reproductions. The credit line must read "NVMA." In the case of photographs, the photographer (if known) and the inventory number must also appear.**
14. A copy of any publication using images from the MONOVA collections is to be donated to the MONOVA. This shall include books, brochures, advertising materials, periodical issues, exhibition catalogues, and videotapes and digital recordings.
15. Failure to meet these conditions will result in forfeiture of the right to use MONOVA photos for publication purposes.
